

Commercial Contract 05/2019 - 01/2022

- Test the controls developed by city employees to identify inaccurate program financial reporting and questioned cost categories that resulted in unsupported obligations for unallowable cost
- Implemented standards operating procedures to reduce waste and fraud for several programs, including confiscated items, restricted grants, T-SPLOST and property taxes
- Reported a gross improper payment rate of less than 10 percent for each program and activity for which an estimate was established
